

## Randolph County EMS

### *Ambulance and Morgue Fee Schedule*

EMS ambulance billing is determined by the level of service provided to the individual patient. The Randolph County Board of Commissioners adopted the following fee schedule for ambulance services and the morgue beginning **July 1, 2024**:

Fee Code	Type of Service	Rate	Explanation
A0428	BLS – Non-Emergency	\$500	Basic Life Support (BLS)
A0429	BLS – Emergency	\$600	Basic Life Support (BLS)
A0426	ALS – Non-Emergency	\$600	Advanced Life Support (ALS)
A0427	ALS – Emergency 1	\$725	Advanced Life Support (ALS)
A0433	ALS – Emergency 2	\$1,000	Advanced Life Support (ALS)
A0434	Specialty/Critical Care	\$1,000	Specialized/Critical Care
A0428	Patient Return	\$500	From hospital.
	Treatment – No Transport	\$250	Provided treatment, medication, or procedure but not transported to a hospital.
	Convalescent Wait Time (Appointment calls only)	\$150	Wait time may be charged beginning after the first 30 minutes at the transport destination. \$200 per hour after that.
	Special Event Standby – Ambulance & Crew. (For-profit events)	\$300	\$300 for the first four hours, then \$50 for every full hour after that.
	Special Event Standby – EMT/Paramedic only.	\$35	\$35 per hour per employee (no ambulance).
	Transport from the scene to the morgue.	\$170	Medical Examiner case / <b>State reimbursed.</b> \$170 for the first 40 miles. Plus, \$1 per mile for every mile over 40.
	Transport from a specialty care facility to the morgue.	\$100	Hospice House, nursing home, or assisted living facility. Not a medical examiner case.
	Daily morgue storage fee for specialty care facilities.	\$50	Per day. Hospice House, nursing home, or assisted living facility. Not a medical examiner case.
	Oxygen administration.	\$20	Per patient when administered.
	Nitrous Oxide	\$100	Per patient when administered.
A0425	Mileage	\$12	Per patient loaded mile.

Our billing service provider will automatically file your insurance claim if the insurance information is provided to EMS at the time of service. If insurance information is unavailable at the time of service, the patient or next-of-kin may contact our billing service to provide the information in a reasonable time, usually within 15 days of the transport. Otherwise, the patient or guardian will be responsible for paying the invoice in full.
